Virginia Academy of Dance Liability Release Form

In recognition of this acknowledged risk of injury, I knowingly and voluntarily waive all right and/or causes of action of any kind, including any and all claims of negligence arising as a result of such activity from which liability could accrue to Virginia Academy of Dance, its officers, agents, employees, instructors, subsidiaries, parent corporations, and all affiliated entities (hereafter collectively referred to as Virginia Academy of Dance)

I hereby agree to release Virginia Academy of Dance and hold Virginia Academy of Dance harmless of all liability, and hereby acknowledge that I knowingly and voluntarily assume full responsibility for all risks of physical injury arising out of active participation in dance on behalf of the participant.
